MEMBERSHIP RATES

We have expanded our membership options to better suit different situations for our members. Children aged 4 and younger are free. Payments may be made by check or cash only, no online/credit/debit payments will be accepted. Applications must be mailed to <u>PO Box 125 Lake Hiawatha</u>, <u>NJ 07034</u> or brought directly to the gatehouse during a registration day. <u>FOR CHILDREN BETWEEN AGES 18-23</u>, <u>PROOF OF ATTENDANCE TO SCHOOL (SCHOOL ID) IS REQUIRED</u>. MEMBERSHIPS WILL BE WITHHELD UNTIL PROOF IS SHOWN.

Membership guidelines:

- Individual memberships are persons 15 and up, anyone aged 14 and below must be joining with an adult (option 2).
- All memberships are for families **residing at the same address.** up to and including the age of 18. Proof of age may be required. If your child is a student in college a copy of their student ID must be presented.
- College students may be added on to options 2-4 but proof of attendance to school must be shown.
- Additional children may be added to option 4 only for \$50 each residing at the same address, proof of residency is required.
- **Substitutions:** A caretaker or grandparent may be substituted for a spouse in option 4, they however cannot be added as a child. If they are to be added on, the \$150 fee will be applied.
- <u>Children</u>: A child aged 4-14 *CANNOT* join alone, they must join with an adult. An adult is a parent/guardian **over the age of 18 living at the same address (Option 2)**. Children 4 years old and under are admitted free of charge. Children aged 4-14 are not allowed to bring in guests.
- No children under the age of 15 will be admitted to the swim club without a supervising adult above the age of 18. Please do not enter with your child and then leave them alone on the property, this will result in loss of membership.



- WE WILL NO LONGER BE USING QR CODES BUT WILL BE RETURNING TO PASSES WITH PICTURES.
- ALL MEMBERS MUST HAVE PICTURES IN ORDER TO RECEIVE YOUR PASSES. IF NOT ALL PHOTOS ARE IN OUR SYSTEM AND NOT ALL MEMBERS ARE PRESENT, YOU WILL NOT RECEIVE YOUR PASSES.
- IF YOU LOSE YOUR PASS, YOU MUST PROVIDE AN ID IN ORDER TO RECEIVE A NEW ONE AND THE COST IS \$10.00

LOCKERS

- Our lockers are available to rent for the entirety of the season, not on a day-by day basis. They must be cleaned out completely before the end of the day on labor day. Any garbage left in a locker will result in a cleaning fee of \$10.00 the following season.
- Locker dimensions: 2 feet wide, 4 feet high, 4 feet deep
- Our lockers can easily fit your chairs and umbrellas!
- You must bring your own lock for your locker.
- The LHSC is not responsible for stolen or damaged items that ARE NOT LOCKED AWAY within your locker.

GUESTS

- THERE ARE NO REFUNDS OR RAINCHECKS FOR GUEST FEES.
- <u>MEMBERS MUST BE PRESENT WHEN GUEST ARRIVES AND STAY FOR THE DURATION OF VISIT.</u>
- There are only daily limits for guests, no seasonal limits.
- ALCOHOL IS NOT PERMITTED AT ANY TIME ON OUR GROUNDS AND WILL RESULT IN YOUR REMOVAL FROM THE GROUNDS AND MEMBERSHIP CANCELLATION..
- Members over the age of 18 may bring up to 3 guests per day.
 - Members aged 17 and under may only bring 2 guests per day.
 - O GUESTS MAY NOT BE UNDER THE AGE OF 15 WHEN THEY COME IN WITH A MINOR.
- If a member wants to bring in more than 4 guests, they must follow the party rate guidelines.
 - This INCLUDES the \$50 maintenance fee.
- Members are ultimately responsible for their guests.
 - If any equipment is damaged, the member will be held responsible.
- Guests must follow all rules of the swim club.
 - o If rules are repeatedly broken, the guest will be asked to leave and may not be able to return.
- Guests aged 4 and under are free of charge

CLOSINGS/WEATHER

- Our general rule is that if after 30 minutes after opening for the day, if we have less than 15 members in attendance the manager is allowed to close.
- We try our best to stay open as long as we can, however, our priority is keeping our members and staff safe. If the forecast looks extremely dangerous, we will close.
- If it is severely raining, thunderstorming, or other extreme weather conditions are on the way, the manager has the right to remain closed/not open for the day as a precaution.
- In the event of a severe weather event, the storm gates on the outside of the parking lot may be closed.
 - PLEASE UNDERSTAND THAT WE DO NOT CONTROL THE STORM GATES. IF THEY DO NOT OPEN, WE CANNOT OPEN.
 - WE CANNOT CONTROL WHEN/IF/HOW THEY OPEN. PLEASE BE PATIENT WITH US!
- We will keep everyone updated about closings through our social media pages, Instagram and Facebook, and through our email and pool voicemail..
 - o Please sign up for our email and text alerts through our website.
- The manager ultimately holds the right to close early, close completely, or stay open depending on the weather conditions called for or currently happening at the moment.

SWIM TEAM

<u>Please take note that this is a swim team for children who have knowledge of swimming, not swim lessons.</u>

Swim team fees are to be paid by separate check. Please do not include swim team fees with your membership fees.

Anyone joining our swim team must be a full **member of the swim club**. Kids under 13 must join with a guardian member, option 2. Swim team applications will not be accepted without a valid QR Code. The Swim Team application is attached separately.

Swim team fees are \$75 per person with a \$150 cap for families with more than 2 children on the team. The swim team will charge a \$50 dollar refundable volunteer fee that will be returned to you when you help with an event. *Events may be fundraising or aiding at a swim meet*.

SWIM LESSONS

- Swim lessons will be offered to members of the club only.
- We will have group sessions and one on one sessions by appointment.
- Dates will be released AFTER opening weekend for the lessons (May 24th, 2025).



NO DIAPERS OF ANY KIND (NOT EVEN SWIMMIES) IN THE MAIN POOL, ABSOLUTELY NO NEGOTIATIONS. YOUR CHILD MUST BE FULLY POTTY TRAINED. IF YOU REMOVE YOUR CHILDS' DIAPER SO THAT THEY CAN SWIM IN THE MAIN POOL AND AN ACCIDENT OCCURS THERE IS A \$500.00 RECLAMATION FEE CHARGED TO YOU BECAUSE WE MUST SHUT DOWN THE POOL TO CLEAN IT. (OUR OTHER MEMBERS LOSE POOL TIME WHICH DOES NOT MAKE THEM HAPPY!)

ALCOHOL AND OTHER RECREATIONAL DRUGS ARE NOT PERMITTED AT ANY TIME ON OUR GROUNDS OR IN THE PARKING LOT. YOU WILL BE ASKED TO LEAVE, HAVE YOUR MEMBERSHIP REVOKED AND LOCAL POLICE WILL BE CALLED.

AS A SAFETY PRECAUTION NO OVERSIZED RAFTS WILL BE ALLOWED ON RAFT DAYS. NO BOATS. NO LARGE FLOATING RAFTS.

WE DO NOT OFFER REFUNDS OR RAINCHECKS FOR INCLEMENT WEATHER. IF IT IS REPORTED TO POSSIBLY RAIN THAT DAY, PLEASE BEAR THIS IN MIND, IF YOU DECIDE TO COME TO THE POOL ANYWAY.

AS MOST AWARE THERE IS A LIFEGUARD SHORTAGE. WE HAVE ALWAYS DONE OUR BEST TO BRING TRAINED GUARDS TO OUR POOL AND CONTINUE TO DO SO. IT IS THE MANAGERS DISCRETION WHETHER BOTH THE SLIDE AND THE DIVING BOARDS WILL BE OPEN AT THE SAME TIME OR THEY MAY ALTERNATE BETWEEN THE TWO DEPENDING ON THE NUMBER OF STAFF THAT DAY.

GENERAL RULES OF THE SWIM CLUB:

PLEASE SEE OUR RULES AND REGULATIONS FOR A MORE DETAILED EXPLANATION OF ALL RULES. THIS IS JUST A SUMMARY OF OUR MOST IMPORTANT RULES.

- NO DIAPERS IN THE MAIN POOL, THIS INCLUDES SWIMMIES.THIS IS NOT UP FOR NEGOTIATION!
- 10 x 10 TENTS AND DOME TENTS AS WELL AS SHADE TENTS MUST BE SET UP AT THE BACK OF THE GROUNDS TOWARD THE SNACK BAR AND BY THE PLAYGROUND AREA. DUE TO SAFETY PRECAUTIONS NOTHING THAT INHIBITS THE SITE OF THE POOL SHALL BE ALLOWED.
- NO RUNNING ON ANY CONCRETE, THIS INCLUDES RUNNING AND JUMPING INTO THE POOL
- YOU MUST USE THE STEPS OR LADDERS TO EXIT THE POOL, NOT THE GUTTERS
- NO EXCESSIVE HORSEPLAY IN THE POOL
- THERE IS NO DIVING INTO THE POOL FROM THE SIDES, ONLY FROM THE DIVING BOARDS
- FOR OUR DIVING BOARDS AND SLIDE; ALL RULES MUST BE OBEYED. IF RULES ARE REPEATEDLY BROKEN, MEMBERS MAY BE ASKED TO EXIT THE POOL OR HAVE RIGHTS TO USE THESE AMENITIES REVOKED FOR A SPECIFIED AMOUNT OF TIME.
- ABSOLUTELY NO FOOD OR DRINKS IN THE POOL OR ON THE CONCRETE POOL DECK.
- MEMBERS ARE TO ONLY PLACE CHAIRS ON THE GRASS, NO CHAIRS WILL BE ALLOWED ON THE POOL DECK
- NO ALCOHOL OR ANY RECREATIONAL DRUGS ARE ALLOWED ON THE PREMISES OR IN THE PARKING LOTS.
 - YOU WILL BE ASKED TO LEAVE AND LOCAL AUTHORITIES WILL BE CALLED AND MEMBERSHIP WILL BE REVOKED.
- NO OVERSIZED RAFTS, BOATS, ETC ON RAFT DAYS AS A SAFETY PRECAUTION



Lake Hiawatha Swim Club, Inc. 2025 Rules and Regulations General

By entering the Lake Hiawatha Swim Club as a Member or Guest you agree to these Rules and Regulations. LHSC is a private owned, members only club.

The Board of Directors has the right to change, modify, suspend, add to, or withdraw any or all of these rules and regulations without notice; and reserves the right to refuse, suspend, or cancel any membership which, in its opinion, is prejudicial to the best interests of the club and its members. Anyone violating these rules and regulations hereafter promulgated may be subject to the cancellation of membership without refunding of membership, locker, or guest fees and may be expelled from the facility.

Section 1: Membership

- 1:1. Membership must be renewed annually. Memberships and lockers are sold on a seasonal basis only. No daily admissions are sold to the public. Refunds are not given for Membership or Locker fees under any circumstances.
- 1:2. Each member older than the age of 4 must scan a pass in order to enter the premises, the photo must match the pass given.
- 1:3. Membership passes cannot be sold, transferred, assigned, or used by non-members.
- 1:4. Members' guests must pay a daily guest fee. No rainchecks for guest fees or refunds will be given for inclement weather.
- 1:5. Any person who has had club privileges or membership privileges suspended or revoked shall not be admitted as a guest.
- 1:6. Members must be present when their guests enter the premises. No Guests may stay after a Member has left the grounds.

Section 2: Operations

- 2:1. The Club reserves the right to modify Club hours or programs without advance notification.
- 2:2. The Club reserves the right to make repairs, replacements, additions, or perform construction during the season.
- 2:3. Members must remove all property from lockers by the end of the last day of the season or it will be considered abandoned and may be disposed of by the Club.
- 2.4. The Club will not be held responsible for personal injuries, or the loss of or damage to personal property or automobiles of members or guests.
- 2:5. The Club reserves the right to regulate the Club parking areas. All persons must comply with handicap parking laws and with posted parking and driving regulations.
- 2:6. Radios and personal speakers are permitted if their operation does not disturb other Club members. The Pool Manager or Head Lifeguard may at any time request these be turned down or off.
- 2:7. The cost of any Club property or recreation room equipment damaged by a member, guest, or child of a member will be charged to the sponsoring member.
- 2:8. The Club Manager, Assistant Manager, or Head Lifeguard may request any member, guest, or any other person to vacate Club property immediately if they believe it is necessary for the safety or comfort of the membership or in the Club's best interests.
- 2:9. Overnight parking is not permitted on Club property
- 2:10-The snack bar is an amenity and is subject to the rules of the Club and may or may not be open at the discretion of the Board of Directors or the Club Managers discretion.

Section 3: Conduct on Club Property

The following are prohibited at all times.

- 3:1. Climbing of trees, fences, or buildings or hanging from any basketball nets, hoops, or backboards is prohibited.
- 3:2. Use and possession of glass containers, alcoholic beverages is prohibited.
- 3:3. Throwing garbage into the pool or leaving litter on any Club property is prohibited.
- 3:4. Abusive language, physical violence, dangerous horseplay, screaming, yelling, pretending to be in distress, or inappropriate sexual behavior is prohibited and you will be asked to leave the grounds.
- 3.5 No pets or animals of any kind allowed on our grounds. We are a private member club.
- 3:6 Changing rooms must be used by all members and no changing of clothes in public view will be allowed.
- 3:7 Operation of bicycles, skateboards, mopeds, or motorized toys. All bicycles, mopeds, and skateboards shall be walked in from the front entrance onto Club property. PLEASE DO NOT RIDE ON THE GRASS!

The following are permitted only when approved by the Pool Manager or Head Lifeguard and then only in designated areas.

- 3:7. Ball playing or other throwing games, including Frisbees.
- 3:8. Use of rafts or other types of flotation devices, including swim aids. No oversized rafts or boats will be permitted.

Section 4: Pool Use

- 4:1. All members and guests must observe rules and regulations established by the State of NJ, Town of Parsippany, Board of Directors, Pool Manager and Lifeguards
- 4:2. The Club reserves the right to close sections of the pool for safety or other considerations without prior notice.
- 4:3. The Manager or Head Lifeguard may evacuate the pool for any health or safety reason at any time.
- 4:4. In the event of lightning or thunder, all persons must evacuate the pool and pool aprons. New Jersey law dictates that the pool and apron may not be reopened until 30 minutes from the last sign of thunder or lightning.
- 4:5. Anyone refusing to evacuate the pool when ordered to do so by the lifeguards will be ejected from the club property.
- 4:6. Patrons must exit the pool by using the ladder or stairs, no one is permitted to climb the gutters to exit.
- 4:7. No games, running, food, drink, smoking, or personal lawn furniture are allowed on the pool apron.
- 4:8. Food and Drinks are not allowed in the pool. Smoking is prohibited on pool grounds.
- 4:9. No free swimming is allowed in or around the diving well.



- 4:10. All bathers must wear proper bathing attire in the pool. No cut-offs, underwear, or thong-type bathing suits are permitted.
- 4:11. Diving is prohibited except from the diving boards.
- 4:12. Pushing into, running into, or cannonballing into the pool from the sides of the pool is not allowed.
- 4:13 DIAPERS ARE NOT PERMITTED IN THE MAIN POOL AT ANY TIME, FOR ANY REASON. THIS INCLUDES SWIM TYPE OR DIAPERS SPECIFICALLY DESIGNATED FOR SWIMMING. A \$500 RECLAMATION FEE MAY BE CHARGED TO ANY MEMBER WHO ENTERS THE POOL AND AN ACCIDENT OCCURS.

Section 5: Age Restrictions

- 5:1. Members must be at least 15 years of age to enter the grounds without a supervising adult.
- 5:2. Members under the age of 18 may only bring in one guest.
- 5:3. Members under the age of 15 must remain in the company and under the direct supervision of an adult aged above 18 years old or sponsor member for the entire time of the member's visit.
- 5:4. Children under the age of 7 must be accompanied by an adult when using the main pool.
- 5:5. Those 8 years of age or younger may use the kiddie pool.
- 5.6. No one under the age of 9 may dive from the high board.
